The credit may not apply during billing cycles with partial usage billed under this contract due to the contract’s start or end dates, or partial bill cycles as determined by the TDSP.

The price does not include federal, state, or local sales taxes or fees, reimbursement for the state miscellaneous gross receipts tax, other government charges, or all other non-recurring fees. Some locations may be subject to a TDSP Underground Facilities and Cost Recovery Charge authorized by their city that is not included in the total average price shown. A Minimum Usage Fee of \$4.99 will apply to billing cycles less than 400 kWh.
