Electricity Price (Residential)

The average price per kWh is based on the usage levels shown above and includes the following components of the price:

- Energy Charge: 12.4¢/kWh
- Mega Saver Credit: \$150.00 if your usage is equal or greater than 2000kWh per bill cycle.
- Pass-Through TDSP Distribution Charge: 5.8272¢/kWh
- Pass-Through TDSP Customer Charge: \$3.24 per month

The Mega Saver Credit applies when consumption billed meets or exceeds 2000 kWh per billing period. Billed consumption may not meet the threshold during partial bill cycles provided by the TDSP or if this agreement has an effective date during an active billing cycle that results in partial billing per this agreement's terms. Your average price for electric service will vary according to your monthly usage.

The average price per kWh does not include JustGreen charge. Customers in the McAllen/Mission area formerly served by Oncor will not be assessed AEP TC-2, TC-3, NDC, or SRC charges or the ADFIT credit associated with the SRC. The price does not include federal, state, or local sales taxes or fees, reimbursement for the state miscellaneous gross receipts tax, other government charges, or all other nonrecurring fees. Some locations may be subject to a TDSP Underground Facilities and Cost Recovery Charge authorized by their city that is not included in the total average price shown. For more details, see the TDSP service tariff for a listing of cities and authorized charges. A Minimum Usage Fee of \$4.99 will apply to billing cycles less than 400 kWh.
