**Electricity Price (Residential)**

The average price per kWh is based on the usage levels shown above and includes the following components of the price:

- Energy Charge: 13.9¢/kWh
- Smart Choice Credit: \$125.00 if your usage on this plan is equal or greater than 1000 kWh per bill cycle.
- Pass-Through TDSP Distribution Charge: 5.8272¢/kWh
- Pass-Through TDSP Customer Charge: \$3.24 per month

Your average price for electric service will vary according to your monthly usage.

The average price per kWh does not include JustGreen charge. Customers in the McAllen/Mission area formerly served by Oncor will not be assessed AEP TC-2, TC-3, NDC, or SRC charges or the ADFIT credit associated with the SRC.

**The Smart Choice Credit is available exclusively under this contract and applies when billed usage under the terms of this contract meets or exceeds 1,000 kWh during a billing cycle. The credit may not apply during billing cycles with partial usage billed under this contract due to the contract’s start or end dates, or partial bill cycles as determined by the TDSP.**

The price does not include federal, state, or local sales taxes or fees, reimbursement for the state miscellaneous gross receipts tax, other government charges, or all other non-recurring fees. Some locations may be subject to a TDSP Underground Facilities and Cost Recovery Charge authorized by their city that is not included in the total average price shown. For more details, see the TDSP service tariff for a listing of cities and authorized charges.

A Minimum Usage Fee of \$4.99 will apply to billing cycles less than 400 kWh.
