Electricity Price (Residential)

This price is based on the usage levels shown above with an estimated 35% consumption during Weekend Hours. Your average price for electric service will vary according to your monthly usage. For example, we have assumed at the 1000 kWh average price calculation above that 350 kWh of usage (35% of the total 1000 kWh in the month) are consumed during the Weekend Hours. **Weekend Hours: 7:00PM Friday- 11:59PM Sunday. Your bill will contain a credit for Energy Charges resulting from energy consumed during Weekend Hours.**

Energy Charge: 25.9¢/kWh. This includes all supply and applicable Transmission and Distribution Service Provider (TDSP) delivery charges as established by the Public Utility Commission of Texas (PUCT).

Base Charge: \$4.95 each billing cycle.

Your average price for electric service will vary according to your monthly usage. The average price per kWh does not include JustGreen charge.

The price does not include federal, state, or local sales taxes or fees, reimbursement for the state miscellaneous gross receipts tax, other government charges, or all other non-recurring fees.

The credit for energy consumed during Weekend Hours is determined using interval usage data from your advanced meter (interval usage data), also provided by the TDSP. You may not receive credits for usage during Weekends Hours on some days of the term if your interval usage data is not available to us from the utility at the time your bill is generated or if you are not billed for that usage.

Some locations may be subject to a TDSP Underground Facilities and Cost Recovery Charge authorized by their city that is not included in the total average price shown. For more details, see the TDSP service tariff for a listing of cities and authorized charges.
