The LED light bulbs are offered through Techniart Incorporated. Just Energy is referred to in this Agreement as "Company". The Customer, also referred to as "you" and "your", is responsible for ensuring the accuracy of the information set out below.

LED Subscription: Customer will receive a pack of 4 LED light bulbs, delivered to the service address on file, every 6 months. The LED light bulbs size and brands may vary. If you need to suspend your subscription, call 1-877-240-3931. Eligibility to change the subscription is at Company's discretion.

LED Delivery: The LED light bulbs will be shipped to the Service Address on file. To change delivery address, please call the phone number at the top. The first LED light bulbs will be shipped within 4-6 weeks.

Charges: There is no charge for choosing the LED light bulb subscription as part of your contract. There will be no separate charges nor any increase in charges on your monthly electricity bill.

Term: The LED light bulb subscription is valid through the duration of your fixed contract term. After your term ends, your subscription will automatically expire. You will not be re-enrolled at the end of your term, and no charges will appear on your bill. To continue coverage at the end of your current fixed term, please call 1-877-240-3931 and your options will be presented to you.

Cancellation: You can cancel at any time by calling 1-877-240-3931. There is no fee for canceling.

Lost/Damaged: If your LED light bulbs arrive damaged, you may request a replacement by contacting us using the information at the top of this page. Requests for replacement are at the sole discretion of Company.

Refunds and Exchanges: Refunds are not applicable with this Subscription. You may not exchange the LED light bulbs for other items or cash.

Warranty
